## **TERMS AND CONDITIONS (Cont.)**

- The information in the Schedule forms part of these Terms and Conditions, which contains the entire understanding and agreement between Philips and the Eligible Consumer entering these Terms and Conditions (you or your). - 15. Consequential Loss: Despite anything to the contrary, to the maximum extent permitted by law, Philips will not be liable under these Terms and Conditions or otherwise for any special, indirect or consequential loss or any loss of profit (including anticipated profit), loss of benefit (including anticipated benefit), loss of revenue, loss of business, loss of goodwill, loss of opportunity, loss of savings (including anticipated savings), loss of reputation, loss of use (including both real and anticipatory) and/ or loss or corruption of data, however arising, whether under statute, contract, equity, tort (including negligence), indemnity or otherwise.
- 17. Liability: Except for any liability that cannot be excluded by law (including the Non-Excludable Guarantees), to the maximum extent permitted by law, Philips (including its respective officers, Consumers and agents) will not be liable to you, and you waive all claims and/or rights that you may have against Philips (and/or its respective officers, Consumers and agents) and release Philips (and its respective officers, Consumers and agents) in respect of any and all liability (including but not limited to all expenses, costs, damages, claims and losses) arising in any way out of or in connection with:
  - (a) any Force Majeure Event;
  - (b) any theft of any Eligible Products or unauthorised access or third-party interference in the Promotion;
