In such situation, Lumileds shall use reasonable efforts to provide equivalent replacement products at similar price, but shall not be held responsible in case there would be no replacement available.

IMPORTANT: This 1-year extended warranty is only valid for Philips LED lights purchased from Australian & New Zealand Philips authorised distributors. It does not cover damage resulting from accident, misuse or abuse, lack of reasonable care, the affixing of any attachment not provided with the product or subjecting the product to any but the specified voltage.

To exercise your rights under this 1-year extended warranty, you must provide proof of purchase in the form of a sales receipt or your submitted 1-year extended warranty registration form that shows the product name or part number and the date of purchase. It is suggested that for your protection you return shipments of product by insured mail, insurance prepaid.
