- j. **Data controller and third parties.** TP Vision Europe B.V., Prins Bernhardplein 200, 1097 JB Amsterdam, the Netherlands is the data controller for your personal data. We may share your personal information with third parties to provide and administer the campaign that you participate in. We always have contractual protections in place for the protection of your personal data. If we process any data outside of the EU, we will take all required measures required for transfer of such data under applicable legislation.
- k. Your rights. You have several rights relating to your personal data.
