

# Financial update to reflect the changes in segment reporting structure

Amsterdam, March 29, 2019

- On January 10, 2019 Philips announced the realignment of the composition of its reporting segments, applicable as of January 1, 2019.
- The most notable changes are the shifts of the Sleep & Respiratory Care business from the Personal Health segment to the renamed Connected Care segment and the main parts of the Healthcare Informatics business from the Connected Care segment to the Diagnosis & Treatment segment.
- The change in segment reporting structure has no impact on total Philips financials.
- · Prior-period financials have been restated to reflect the above changes.
- Financial reporting is according to IFRS. The definition of non-IFRS information can be found in chapter 10 'Other information' of The Annual Report of 2018.
- As disclosed in the Annual Report 2018, IFRS 16 leases is applicable as of January 1, 2019.
  Prior years comparative information related to IFRS 16 standard change has not been restated.
- The impact of adopting IFRS 16 on the key financial measures income from operations, EBITA and Adjusted EBITA are not considered material. The impact on Adjusted EBITDA is approximately EUR 150 million improvement for full year 2019, reflecting the depreciation on the leases capitalized under the new standard.
